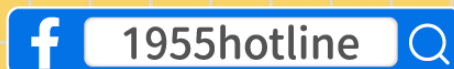
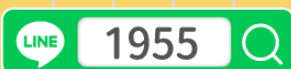

Preventing dummy accounts



Anyone who provides a fraud gang with an account to which they remit money is an accomplice to the crimes of illegally **aiding and abetting fraud** and **money laundering in violation of the Money laundering Prevention Act.**



Most people who ask to borrow **a bank passbook, ATM card and password** will use them to engage in illegal activity.

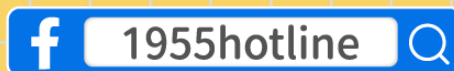


Only criminals trying to **hide** their real identity and cash flow use the accounts of others.



Allowing others to use your bank account could be a violation of the Employment Service Act and not only **runs the risk of having your employment permit revoked** but also of being **sentenced by a court** and victims seeking reimbursement for the full amount they have been defrauded.

Pencegahan Rekening Penipuan



Memberikan rekening untuk mentransfer uang hasil penipuan akan menjadikan Anda sebagai anggota sindikat penipuan. **Membantu kejahatan penipuan** dapat melanggar **hukum pidana**, dan **membantu pencucian uang** dapat melanggar **Undang-Undang Pencegahan Pencucian Uang!**



Jika ada yang meminta **buku tabungan, kartu ATM, dan kata sandi**, besar kemungkinan mereka berencana menggunakannya untuk aktivitas ilegal.



Pelaku kejahatan yang ingin **menyembunyikan identitas** dan aliran dana asli mereka, biasanya akan memanfaatkan rekening orang lain.



Sembarangan memberikan rekening Anda kepada orang lain, bisa kemungkinan melanggar Undang-Undang Ketenagakerjaan, **berisiko kehilangan izin kerja**, bahkan bisa **dijatuh hukuman oleh pihak pengadilan**. Selain itu, Anda juga bisa menjadi target tuntutan ganti rugi untuk seluruh jumlah uang yang telah ditipu!

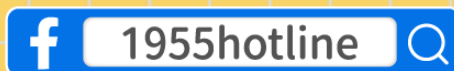
Chỉ có tội phạm mới sử dụng tài khoản ngân hàng của người khác để **che giấu** danh tính và dòng tiền của mình.



Tùy tiện cung cấp tài khoản cho người khác, có thể sẽ vi phạm Luật Dịch vụ Việc làm.

Có khả năng bị thu hồi giấy phép lao động, bị tòa án kết án, nạn nhân cũng có thể yêu cầu bồi thường toàn bộ số tiền bị lừa đảo!
